CHAIRPERSON'S STATEMENT

I am happy to share with you the Performance Report for the Independent Policing Oversight Authority for the period July - December FY 2023/24. The Report sheds light on what we have collectively achieved towards advancing civilian oversight and promotion of public trust and confidence in the National Police Service.

The Authority aligns its strategies to the Kenya Vision 2030, UN Sustainable Development Goals, the fourth Medium Term Plans 2023-2027 and the BETA priorities among other blueprints in order to realize its mandate. The strategic focus of the Authority is building public confidence and trust in policing, ensuring compliance to human rights standards and fundamental freedoms among other key objectives.



In the period under review, the Authority received complaints and processed them through investigations, monitoring of police operations, inspections of police facilities and referral to other agencies for action.

In line with its mission as stipulated in the current strategic plan (2019-2024), the Authority has continued to conduct impartial and independent investigations on police misconduct, inspections of police premises and monitoring of police operations affecting members of the Public. This continues to enhance professionalism and integrity in the Police Service.

Since its inception, the Authority has received 28,850 complaints and consequently, 5,058 investigations have been completed. The completion of investigations has gradually increased throughout the period due to growth in staffing levels and capacity building of serving officers. The Authority has also conducted inspections in 4,081 detention facilities and police premises.

Additionally, 623 police operations were monitored to ensure that police operations were carried out professionally and within the confines of the law. The findings from these inspection of police premises and monitoring of police operations informed recommendations which were made towards improvement of the NPS.

I also acknowledge my fellow members of the Board for their commitment towards realizing our institutional mandate. I also wish to thank the IPOA secretariat for their dedication that contributed to the achievements captured during this performance period.

Lastly, the Authority appreciates the support extended by the Government and the development partner community which continues to be critical to the success of our operations.

DIRECTOR / CHIEF EXECUTIVE OFFICER'S STATEMENT

During the period under review, the Authority received and processed 2,152 complaints, concluded 298 investigations, inspected 195 police facilities and monitored 39 police operations. IPOA also implemented various strategies to enhance visibility, strengthen stakeholder cooperation and complementarity.

This performance report presents the Authority's achievements in enhancing police accountability. Throughout this period, the Authority made concerted efforts to expedite investigations into allegations of police misconduct. IPOA also undertook preventive initiatives by conducting inspections in various police facilities and monitoring of police operations across the country.



For accountability and reporting on its operations, IPOA published reports and printed IEC materials which were distributed during stakeholder engagement and outreach forums. The Authority also released press statements and facilitated media interviews as circumstances demanded.

During the period under review, the Authority prepared its FY2024/25 budget under the Governance Justice Law and Order Sector (GJLOs). Consequently, IPOA was allocated a budget of Kes. 1094.94 million for the recurrent budget estimate against a resource requirement of Kes 2,311 million which comprised of Kshs. 2,011 million recurrent budget and Kshs.300 million development budget, IPOA is yet to defend its ceiling at the National Treasury and Parliament in quarter 3.

I would like to thank the Board for its continued policy guidance and support throughout the period. During this period, the Board endeavored to ensure that the Authority delivered on its mandate efficiently and effectively. I also extend special thanks to the staff for their commitment and dedication to service delivery.

As IPOA assures the public and other stakeholders of its commitment in guarding public interest in policing, I also implore all stakeholders to read this performance report to keep abreast with the Authority's achievements, challenges and recommendations.

EXECUTIVE SUMMARY

During the reporting period, the Authority received and processed 2,152 complaints through investigations, monitoring of police operations, inspections of police and detention facilities while others were referred to other agencies. These complaints were lodged by members of the public, police officers besides state and non-state organizations. The Authority also took up some matters on its own motion¹.

IPOA conducted 298 investigations out of which 78 were forwarded to the office of the Director of Public Prosecutions for review. The rest are still under active investigations while 2 convictions were made. Cumulatively, 210 cases were before court as at 31st December 2023.

The Authority also conducted 195 inspections of police premises and detention facilities. This included 94 new inspections, 100 follow-up inspections² and 1 thematic³ inspection. 39 policing operations were monitored including 28 on public order management, 1 security operation, 2 on traffic management and 8 on beats and patrols⁴. Consequently, these technical functions informed recommendations that were made to the National Police Service and other relevant actors.

Besides this, IPOA engaged local and international media and released press statements to appraise stakeholders of its position on technical matters whenever need arose. The Authority also regularly disseminated information and news through its digital platforms to ensure mass sensitisation on key developments. This outreach strategies enhanced stakeholder engagement and complementarity.

Despite these achievements, IPOA also experienced challenges that affected its operations including inadequate funding, non-cooperation by some witnesses and NPS officers besides the paradox created by parallel investigations between the Authority and DCI into the same matters. IPOA recommends enhanced budgetary allocation by the National Treasury and compliance with Section 10(m) of the NPS Act on cooperation and implementation of IPOA's recommendations.

1. INTRODUCTION

1.1 Background

The Independent Policing Oversight Authority is established under Cap 86 of the Laws of Kenya. Its main function is to provide civilian oversight over the work of the Police.

The objectives of the Authority as set out in Section 5 of the Independent Policing Oversight Authority Act are to:

- (a) Hold the Police accountable to the public in the performance of their functions;
- (b) Give effect to the provision of Article 244 of the Constitution that the Police shall strive for professionalism and discipline and shall promote and practice transparency and accountability; and
- (c) Ensure independent oversight of the handling of complaints by the Service.

Under Section 30 of the IPOA Act; the Authority submits a report of the performance of its functions to the Cabinet Secretary at least once every six months making such recommendations as it may consider necessary. The Cabinet Secretary publishes and presents the report before the National Assembly within 14 days of receiving the report. This report complies with the above-mentioned statutory requirement.

1.2 Principal Functions

The Authority's principal functions as laid out under Section 6 of the Authority's Act are to:

- a) Investigate any complaints related to disciplinary or criminal offenses committed by any member of the National Police Service, whether on its motion or receipt of a complaint, and make recommendations to the relevant authorities, including recommendations for prosecution, compensation, internal disciplinary action, or any other appropriate relief, and shall make public the response received to these recommendations;
- b) Receive and investigate complaints by members of the Police Service;
- c) Monitor and investigate policing operations affecting members of the public;
- d) Monitor, review, and audit investigations and actions were taken by the Internal Affairs Unit of the Police Service in response to complaints against the Police and keep a record of all such complaints regardless of where they have been first reported and what action has been taken;
- e) Conduct inspections of Police premises, including detention facilities under the control of the Service;
- f) Co-operate with other institutions on issues of Police oversight, including other State organs concerning services offered by them;
- g) Review the patterns of Police misconduct and the functioning of the internal disciplinary process;
- h) Present any information it deems appropriate to an inquest conducted by a court of law;
- i) Take all reasonable steps to facilitate access to the Authority's services to the public;
- j) Subject to the Constitution and the laws related to freedom of information, publish findings of its investigations, monitoring, reviews, and audits as it seems fit, including through the electronic or printed media;
- k) Make recommendations to the Police Service or any State organ;
- l) Report on all its functions under its Act or any written law; and
- m) Perform such other functions as may be necessary for promoting the objectives for which the Authority is established.

2. POLICE ACCOUNTABILITY

As a civilian oversight body, the Authority executes various functions aimed at ensuring police accountability. These include receiving and processing complaints on police misconduct, conducting independent investigations, inspecting police premises including police detention facilities, and monitoring police operations affecting members of the public.

2.1 Complaints Management

The IPOA Act No. 35 of 2011 requires the Authority to ensure independent oversight of the handling of complaints against the NPS. The Authority executed this function through the receipt and processing of complaints lodged against Police officers.

The IPOA Act provides that the Authority may receive and investigate complaints related to disciplinary or criminal offenses committed by members of the Police Service when.

- a. Reported by members of the public.
- b. Reported by members of the NPS.
- c. On the Authority's own motion.

2.1.1 Complaints Received

The Authority received and processed 2,152 complaints across the country through the nine regions as indicated in figure below.

2.1.2 Mode of Receipt

To enhance police accountability, the Authority has put in place various modes to enhance lodging of complaints which include walk-ins, letters, police notifications, e-mail, outreach programmes, toll-free driven call center, and through digital platforms comprising the Authority's institutional website, blog and social media. The figure below shows the different modes used in lodging complaints during the reporting period.












Figure 2: Mode of receipt of the Complaints processed.

Out of a total of 2,152 complaints received during the period, 1,396 were lodged by members of the public while 376 were from people complaining on behalf of others. Other incidents of police misconduct (193) were taken up through IPOA's own motion⁵ while 69 were lodged by members of the National Police Service. The remaining 71 were lodged by state actors while 47 were from non-state organizations⁶.

2.1.4 Nature of Complaints Received

Six hundred and thirty-one (631) complaints received by IPOA were on police inaction followed by abuse of office (286). There were 96 deaths as a result of police actions or inactions recorded during the reporting period.

2.1.5 Complaints Processing

The Authority made various recommendations to resolve the lodged complaints through an internal case intake committee (CIC). The CIC is a first point of contact for all complaints and determines how complaints are resolved. The CIC makes recommendations for complaints resolution through investigations, inspection of police facilities or monitoring of policing operations. The rest of the complaints were resolved through preliminary inquiries while others were referred to the relevant agencies depending on their nature.

The figure below indicates the method of resolution of the complaints received during the period under review.








Figure 3: Method of resolving the complaints.

2.1.6 Complaints referred to the Internal Affairs Unit (IAU)

The Authority worked closely with the IAU to enhance an effective and efficient complaints handling mechanism by the members of the National Police Service.

During the period, the Authority referred 4 complaints to the IAU which provided feedback on 16 files including those that IPOA had referred to the unit in the previous reporting period.

2.2 Counselling and Psychosocial Support

The Authority provided psychosocial support to 217 clients (95 male and 122 female). Out of the 217 clients, 35 were complainants or witnesses while the rest were IPOA staff members. They were taken through counselling and debriefing as indicated in the table below.




Figure 4: Counselling and Psychosocial services provided

2.3. Investigations of Police Misconduct

Section 6(a) of the IPOA Act mandates the Authority to investigate complaints related to disciplinary or criminal offenses committed by members of the Service.

In the period under review, the Authority completed 298 investigations. Out of these, 78 cases were forwarded to the ODPP for review. As of 31st December 2023, 210 cases were before courts out of which 182 were investigated directly by the Authority while 28 were monitored

having been investigated by the police7. During the period, the courts convicted former police officers in two of the Authority's investigation cases.

2.4 Inspection of Police Premises and Detention Facilities

Section 6(e) of the IPOA Act mandates the Authority to conduct inspections of police premises, including detention facilities under the control of the National Police Service to ensure adherence to human rights standards in policing.

2.4.1 Police Premises Inspected

IPOA conducted 195 inspections in various NPS facilities across the country which included 94 new inspections, 100 follow-ups in KPS facilities and 1 thematic inspection following a death in police custody.

The 94 new inspections conducted included 4 in specialized units, 2 in DCI and 88 in KPS facilities.

2.4.1.1 Parameters Assessed during the Follow- Up Inspections

Parameters assessed during the initial inspections were reassessed in the subsequent followup inspections to highlight the level of implementation. The table below shows the findings.

2.5 Monitoring of Policing Operations

Section 6 (c) of the IPOA Act mandates the Authority to monitor and investigate policing operations affecting members of the public. The monitoring aims to ensure that Police operations ensuring that Police operations are carried out within the confines of the law and with strict adherence to human rights standards.

The Authority carried out 39 monitoring activities which included 28 Public Order Management, 1 security operation, 2 traffic control operations, and 8 on beats and patrol.

There was notable improvement on the level of professionalism by the NPS during public order management and security operations. However, instances of police misconduct were documented in traffic management, assemblies and beats and patrols. In addition, cases of bribery, extortion, harassment, excessive use of force and failure to affix name tags during operations were detected. The Authority also observed that Police officers were not adequately equipped during operations.







3. STAKEHOLDER COOPERATION AND COMPLEMENTARITY

3.1 Stakeholders Engagement

The Authority engaged with various stakeholder institutions including governments, State and Non-State actors, non-governmental organizations, civil society and electoral observer missions to strengthen the existing cooperation with them as detailed in Table 1 below.

Further, the Authority also expressed its position on public interest matters physically and through press statements disseminated across various international and local media. In the period, IPOA maintained informed stakeholders through its social media platforms as well:

3.2 Branding and Awareness Creation

The Authority published and broadcasted Information, Education and Communication materials during stakeholder engagement forums. Strategically, the Authority targeted police officers, stakeholder institutions and members of the public during the various awareness creation and outreach programmes carried out during the period.

4. RESEARCH AND INFORMATION MANAGEMENT

4.1 Research

The Authority conducts research to inform policy and decision making. During the period, the Authority conducted a recommendation tracking exercise in various parts of the Country. The exercise was aimed at establishing the extent of action on recommendations made by IMPS officers during routine inspections at police facilities.

The assessment covered recommendations made to the NPS by the Authority. This exercise was conducted in 23 Counties¹² in the month of September 2023. The recommendations were categorized into 14 thematic areas¹³.

The exercise was conducted in 102 Police Stations that were purposively selected across 23 Counties. The survey targeted police stations where recommendations had been made during the implementation of the functional areas and recommendations made to the NPS through various reports.

The tracking of recommendations took an evaluation approach where IPOA officers visited selected Police stations to assess the progress of implementation. The report is undergoing internal review and approval and subsequently publishing.

5. INSTITUTIONAL CAPACITY

5.1 Resource Mobilization and Financial Management

During the period under review, the Authority prepared its FY2024/25 budget under the Governance Justice Law and Order Sector (GJLOs). IPOA was allocated a budget of Kes. 1094.94 million for the recurrent budget estimate against a resource requirement of Kes 2,311 million which comprised of Kshs. 2,011 million recurrent budget and Kshs.300 million development budget, IPOA is yet to defend its ceiling at the National Treasury and parliament in quarter 3.

The Authority's annual report and financial statements for the FY2022-23 were prepared, reported, and audited in accordance with the provisions of Articles 226 and 229 of the Constitution, Public Finance Management Act 2012 and Public Audit Act No.34 of 2015. The Authority obtained a clean audit report for both the recurrent and staff mortgage and car loan scheme.

The Authority's approved budget for the FY2023/24 was Kes. 1,052.7 million. However, the budget was revised downwards by Kes.33.43 million to Kes. 1,019.27 million in supplementary estimates I. During the half year period ended 31st December 2023, IPOA received Kshs. 486,930,307 in the form of exchequer releases and recorded a total expenditure of Kshs. 422,116,653 representing an absorption rate of 41% of the revised budget. The actual expenditure comprised the following: Kshs. 256,930,860 on compensation of employees; Kshs. 164,231,562 on use goods and services; Kshs. 856,461 on social security benefits; and Kshs. 97,770 on acquisition of assets.

The Authority also participated in the FiRe Awards 2023 which focused on the FY 2021/23 and emerged the winner in the category of Constitutional Commissions and Independent offices-IPSAS cash basis category.

5.2 Automation

The Authority achieved significant milestones towards the overall objective of strengthening business systems and internal processes through continuous monitoring of automated systems and infrastructure.

The Authority has successfully onboarded its complaints intake form onto the e-citizen platform, enabling complainants to access IPOA's services more efficiently. This is an interim measure as the Authority continues to work on completing the portal. The completed portal will be more robust and integrated with the Enterprise Content Management (ECM) system, facilitating realtime intake and processing of complaints.

5.3 Learning and Growth

The Authority facilitated training of 16 officers for various courses including SLDP, SMC supervisory course and report writing at the Kenya School of Government. In addition, 96 officers undertook various trainings including 40 officers trained on trauma informed care and 34 on effective management of meetings, minutes and Board papers writing. The legal officers in the authority were trained on conducting legal audit by the Kenya School of Law.

5.4 Review of Organizational Structure and HR Policies

The Authority submitted the reviewed HR instruments to the Public Service Commission for approval. The Commission approved the organizational structure and staff establishment. The instruments review was in line with the Constitution, relevant legislations, government circulars, regulations & guidelines, current emerging trends in labor market and projected growth of the Authority.









In the newly approved instruments, the Authority's establishment expanded from 326 to 1377 members of staff across various functional areas based on 9 regional offices and 24 county offices. The grading structure was also expanded from 9 to 13 cadres.

6.0 CONCLUSION

In a bid to achieve police professionalism as stipulated by Article 244 of the Constitution, IPOA continues to strengthen its policing oversight role through significant sustained gains and achievements. The Authority recognizes the crucial role that the National Police Service plays in the provision of professional and people-centered policing to uphold the rule of law for a safe and secure society.

The Authority remains steadfast in its collective responsibility as an independent policing oversight body. The continued collaboration with the stakeholders and partners and the support accorded to the Authority by the National government has made it possible for the achievements made so far.

7.0 CHALLENGES AND RECOMMENDATIONS

7.1 Challenges Experienced by the Authority

During the reporting period, the Authority faced the following challenges:

- a) Inadequate annual budget allocation.
- b) Non-cooperation by some witness and NPS officers.

8.0 RECOMMENDATIONS

8.1 Recommendations to Challenges Experienced by the Authority

- a) Enhanced budgetary allocation by the National Treasury for effective service delivery.
- b) Strengthened Cooperation by the NPS officers and witnesses.
- c) The IG to ensure that the suspect police officers cooperate and comply with arrest warrants and summons.
- d) The Inspector General to facilitate fast tracking of cases and matters referred to the NPS to avoid delay.

8.2 Recommendations to the Service

According to Section 6(k) of the IPOA Act, the Authority is mandated to make recommendations to the Service. In this regard, the Authority recommends the following:

- a) Inadequate Resource Allocation: The Inspector General of Police should, as stipulated in National Police Service Act 2011, Section 116(2) ensure adequate and fair distribution of Finances and Resources to fund Police premises. The Inspector General should therefore establish a proper Accounting System and fair distribution of the available resources for good Policing in all areas.
- b) Understrength and gender imbalance: The National Police Service Commission should ensure that shortage of staff and gender imbalance are addressed to ensure compliance with the third gender rule as enshrined in the Constitution.
- c) Poor Police Infrastructure: The CS interior to spearhead the establishment of NPS Development Fund for improving and building new Police Infrastructure in a bid to modernise National Police Service facilities. This is regard to office spaces, cells (gender and age), Child Protection Units, and acquisition of Police land especially the newly







- gazetted police facilities. Section 10(1(f) of NPS Act 2011 provides that; It is the function of the Inspector General of Police to provide funds for establishment of Police premises.
- d) Records Management: The Officer in-charge of the Police facility to ensure that records are kept and maintained in accordance to Chapter 59 of the Service Standing Orders and strict adherence to Appendix 59(a) of Service Standing Orders. Additionally, there is need of streamlining the issuance of Police registers and stationeries in all Police premises.
- e) Separation of detainees by gender and age: The IG and the Officers in charge of the station should ensure adherence to the fifth schedule Rule 5(c&d) that men and women, juvenile or children and adults be kept separately.
- f) Micro-chipping of Police dogs: As envisioned in Chapter 51(5)(2) of the Service Standing orders, the IG together with the Dog Masters should ensure that all police dogs are micro-chipped.
- g) Training of more veterinary doctors: The IG should ensure that at least 3 animal health assistants are available per region for adequate and effective maintenance of the Police Dogs. Additionally, capacity building of K9 officers on dog handling, maintenance of Police Dogs and other aspects in relation to the SSO should be ensured.
- h) NPS training and tooling: The IGP NPS should ensure adequate training of its officers prior to embarking on any operation affecting members of the public. Additionally, NPS officers should be sufficiently kitted to avoid exposure of officers to injury and harm.
- i) Enhanced supervision of Police Officers conducting beats and patrols: The IG should ensure compliance to provisions of SSO¹⁴ on supervision of Police Officers conducting beats and patrol to enhance effectiveness and accountability of the patrol teams.
- j) Adequate supply of high-powered HF and VHF: The IG to ensure adequate supply of High-powered HF and VHF Radios to boost communication in remote police operational areas.
- k) Adequate tooling and equipping: The IG to ensure adequate equipping and tooling of the NPS officers during police operations.

POA in a nutshell

THE IPOA FUNCTIONS

- 1. To investigate deaths and serious injuries caused by Police action: IPOA investigates deaths and serious injuries arising from Police action and recommends disciplinary action or prosecution to prevent impunity and enhance accountability within the NPS.
- **2. To investigate Police misconduct:** IPOA receives complaints from members of the public and Police on Police misconduct and undertakes independent investigations. IPOA can also initiate investigations on its own motion and may refer cases to appropriate bodies including seeking the courts intervention to have its recommendations implemented.
- **3.** To monitor, review and audit investigations and actions by Internal Affairs Unit of the Police: IPOA oversees the work of the Internal Affairs Unit (IAU) of the Police to independently verify that the internal Police system deals with complaints against officers fairly and effectively. The Authority can take over investigations if not satisfied with IAU's intervention.
- **4.** To conduct inspections at Police premises: This seeks to ensure that Police premises meet basic predefined standards and that of suspects and detainees is in line with the Constitutional principles.
- **5.** To monitor Police operations affecting members of the public: IPOA independently scrutinizes policing operations affecting members of the public to ensure policing is conducted for the benefit of the people of Kenya. Where excessive use of force and abuse of power is detected, independent investigations and remedial action is recommended.
- **6.** To review the functioning of the internal disciplinary process: IPOA monitors internal Police disciplinary processes to ensure fairness and effectiveness and may conduct surveys to assess improvement in Police internal accountability mechanisms.
- **7. Reporting:** IPOA is required to prepare a performance report every six months and an annual report to inform the public of its activities and provide recommendations for improvement of the functioning of the NPS.

FREQUENTLY ASKED QUESTIONS

- 1. Is IPOA part of the Police? IPOA is not part of the National Police Service. It is an independent authority established under the Independent Policing Oversight Authority Act (No. 35 of 2011) to provide for civilian oversight over the work of the Police in Kenya. Article 244 of the Constitution requires the Police to strive for the highest levels of the discipline and professionalism: promote and practice, transparency and accountability in execution of their duties. Under the law, IPOA holds them accountable to this standard.
- **2.** Does IPOA take complaints directly from the public? Yes, individuals and organisations who have specific complaints regarding Police action or conduct are free to make formal complaints to IPOA for investigation.
- **3.** How do I file a complaint? A complaint can be filed through a visit to the IPOA offices, a telephone call, the IPOA website, a letter or email. You can also dial the toll-free number 1559 to lodge your complaint.
- **4. What happens after my complaint is received?** All complaints received are processed through the Complaints Management System and necessary action scheduled and undertaken by the complaints team which comprises investigative and legal teams.
- **5.** Does IPOA have capacity to investigate all complaints? Though IPOA is continually building human resource and technical capacity, the Authority endeavours to attend to all complaints within a reasonable time period. Complaints that fall outside the IPOA mandate area may be forwarded to the Internal Affairs Unit of the National Police Service or to a responsible officer for appropriate action. In every case, effort will be made to resolve the issue and notify the complainant.
- **6. What happens to an officer who is found culpable?** IPOA has power to recommend prosecution and/or disciplinary action for an officer who is found to have violated the law or acted in a manner that brings disrepute to the National Police Service. IPOA may also recommend a change in process or procedures of the National Police Service.
- 7. What is the responsibility of the National Police Service Commission and the Office of the Inspector General? The National Police Service Commission (NPSC) is a constitutional body established under Article 246 of the Constitution. The NPSC shall recruit and appoint persons to hold offices in the service, confirm appointments, and determine promotions and transfers within the National Police Service. The Inspector General (IG) is the overall commander of the National Police Service exercising independent control and management of the service. The IG is assisted by two deputies in-charge of the Kenya Police and the Administration Police.
- **8. What can I complain about?** IPOA receives complaints relating to Police misconduct and criminal action or inaction by the Police.
- **9. Can Police themselves raise complaints with IPOA?** Yes, Police officers can record formal complaints with IPOA regarding misconduct by their colleagues or superiors.
- **10.** What constitutes the functions and responsibilities of IPOA? IPOA's functions and responsibilities are spelt out in Section 6 of the Independent Policing Oversight Authority Act.
